The shop rate for restoration, repairs and/or service is \$105.00 per hour. Shop supplies and parts will be billed as used. Special order parts, chrome, upholstery and similar items not in our inventory will be billed when ordered or received for your vehicle. Supplies, parts, items for your vehicle and charges for service are billed every 30 days and are due upon receipt of the invoice. An initial \$1000.00 deposit (US dollars only) is required along with this contract An additional initial deposit may be required depending on the extent of restoration on your vehicle.

You agree that we may publish or post pictures and/or videos on our website of your vehicle being repaired or restored at Wildrick Restoration. Any such photos or videos taken by us are the sole property of Wildrick Restoration.

We charge a storage fee of \$115.00 per month for any vehicle waiting on: scheduling of work; payment from you; additional restoration, service, or repairs for work you have requested which is not yet scheduled; and completed vehicles waiting for payment and/or pick up by you. All Wildrick Restoration and related companies' invoices on your vehicle must be paid in full before your vehicle will be released to you or your agent. If you fail to pay our invoices when due, we will stop working on your vehicle and charge you storage fees. In the event payment is not timely made, you agree to pay on all invoices more than 30 days old 18% per annum, together with court costs and attorney fees which we may incur in enforcing this contract, all without relief from valuation and appraisal laws. If legal action becomes necessary, you agree that this contract will be governed by the laws of the State of Indiana and that jurisdiction and preferred venue shall be in a court in Shelby County, Indiana.

Wildrick Restoration requires that the owner carry vehicle insurance coverage for the value of the above listed vehicle while it is located at Wildrick Restoration for repairs, restoration, service and/or storage. Commercial Property and Liability insurance coverage is carried by Wildrick Restoration, L.L.C.

IF TRANSPORT IS DELIVERING YOUR CAR, PRIOR TO DELIVERY, PLEASE MAIL A LIST OF RESTORATION/REPAIRS/SERVICE TO BE COMPLETED ALONG WITH THIS CONTRACT AND DEPOSIT. ONCE WE RECEIVE THE SIGNED CONTRACT WITH THE DEPOSIT, WE WILL SCHEDULE A TIME TO RECEIVE THE CAR SO YOU MAY PROCEED WITH SCHEDULING TRANSPORT. YOU ARE RESPONSIBLE FOR COSTS OF TRANSPORTING YOUR CAR TO AND FROM OUR PLACE OF BUSINESS.

Warranty:

Wildrick Restoration warrants that their work passes without objection in the trade and is free from defects in material and workmanship under appropriate use, driving conditions and service for a period after final invoice of 90 days or 3,000 miles, whichever occurs first. Our only obligation under this warranty is to repair or replace, at our option, the defective part or work at our place of business. If you suspect any of our work or parts maybe defective, you must call and notify us immediately or the warranty will be voided. You are responsible for costs of return and pick up of your vehicle for warranty work. We are not responsible for loss or any incidental or consequential damages or expenses of any kind. This warranty is voided by misuse, alteration, accident or neglect. **This warranty is exclusive and in lieu of all other warranties, including merchantability and fitness for a particular purpose. Provided however, no warranty is provided for engine work and repairs performed by Wildrick Restoration unless Wildrick Restoration also installs the engine in your car.**
